## C. TERMS & CONDITIONS

- 1. Only those OEM's (original equipment manufacturers) and authorised dealers/suppliers of Silent DG Set, who have minimum 3 years of experience in the field of undertaking similar works for Government/Banks/Reputed Companies and who fulfill the following prequalification criteria are eligible to tender:
  - (a) Minimum 5 years of experience in undertaking similar nature of works
  - (b) Minimum yearly turnover of at least **US\$60,000.00** during last 3 years supported by audited financial statements.
  - (c) Service and Maintenance facilities in Yangon.
  - (d) Strong testimonials on service guaranty by clients in Myanmar.
  - (e) Replacement Guarantee of 1 year. The vendor shall replace the DG Set in case of any major problem occurs within 1 year from the date of handing over of DG Set.
- 2. Bidders should submit copies of 2 Work Orders indicating scope and value of Purchase Orders for the supply & Installation of Silent DG Sets and completion certificate for the qualifying works.
- 3. Bids submitted by a firm who is found to be not satisfying the above criteria will be rejected.
- 4. The bidders should inspect the site on any working day before submitting the bids.
- 5. The bid should be submitted in a sealed envelope clearly mentioning as "Technical Bid" and "Financial Bid" and these two sealed envelopes should be put into a big envelope. Replacement Guarantee (not just warranty) should be valid for 1 year from the date of handing over of DG Set.
- 6. The last date of submission of sealed bid offer as mentioned above is **05.12.2017 (1100 hrs).** The sealed envelope addressed to Head of

Chancery, Embassy of India, 545-547 Merchant Street, Yangon may be submitted at the Reception during the working hours before the last date & time.

- 7. In the first stage, only technical bids will be opened for evaluation and Financial Bids of only those bidders whose technical bids are acceptable/ qualified will be opened on the same day after evaluation of technical bid. The representatives of the bidders, if they wish, may remain present while opening of the technical bids and financial bids.
- 9. All the pages/documents of the bid should bear the signature of the bidder with date. All the entries by the bidder should be in one ink & legibly written. Any over-writing corrections & cuttings should bear dated initials of the bidder. Corrections should be made by writing-again instead of shaping or over-writing.
- 10. Rates should be quoted both in figures as well as in words. In case the rates quoted in words & figures are at variance, the rates written in words will be taken as final.

## D. SCOPE OF WORK

- 1. The scope of work of the bidder in brief is enumerated below:
  - (a) Supplying, installation, testing and commissioning of DG Set (250 KVA) complete with acoustic enclosure, circuit breaker, 24V battery pack, base fuel tank, display screen with analogical values and AMF panel.
  - (b) All Civil Works, **if required** for the preparation of Platform (PCC foundation of appropriate size at least 9 inches above the ground, length and width of the Foundation should be atleast 200mm to 400mm more than that of the DG set size to ensure the least

vibration, foundation must be rigid) necessary for the installation of the Silent DG Sets.

- (c) Proper earthing required for the installation of Silent DG Sets and protection of equipment and Human being. Copper/GI plate earthing with Copper/GI plate of minimum size 600\*600\*3 mm and Copper/GI strip of size 25\*3 mm laid in ground at a depth of 12 feet complete with Charcoal, Salt and Manhole cover etc.
- (d) Supply, installation and testing of Changeover and other electrical fittings, cables etc. required for the installation of DG Sets
- (e) Arrangement of equipment, tool and tackles and scaffolding material for installation of the equipment at site at the cost of bidder.
- (f) Required quantity of lubricant and coolant are to be arranged by bidder at the cost of bidder till commissioning and handing over the system and during the guarantee period of one year.
- (g) Submission of guarantee certificate and test certificates of the manufacturer.
- (h) Installation of exhaust pipes with suitable insulation up to the required level of the building as required by the concerned statutory authorities.
- (i) Cleaning and removal of all unused / wastage material from the site immediately after handing over the equipment.
- 2. The existing 140 KVA DG set has to be dismantled and taken away by **offering a buy back** for value for the same.
- 3. The bidder shall, at their own expense, arrange for safety provisions as per safety codes and Rules, Regulations and Laws as may be applicable, in respect of all labour, directly or indirectly employed in the work.
- 4. The bidder shall not assign the contract or any part thereof without the prior written consent /approval of the Embassy of India, Yangon.

  - (a) The bidder withdraws its offer during the period of tender validity.
  - (b) After submission of bid, the bidder fails to honour the order or refuses to comply with any or all terms and conditions as mentioned in the tender document.
- 3. The EMDs of the unsuccessful bidders will be refunded without any interest after awarding of bid to successful bidder. EMD of successful bidder will be returned after retention of Performance Guarantee.

#### G. PERFORMANCE GUARANTEE

1. Five percent (5%) of PO value will be retained as Performance Guarantee for the entire period of replacement guarantee of 1 year from the date of handing over the DG Set. This amount will be released on completion of guarantee period.



2. The losses to the Embassy, if any, which are directly attributable to the firm shall be deducted from the bills /adjusted from the performance guarantee.

#### H. VALIDITY OF BID

1. The offer should be valid for a minimum period of **three months** from the date of opening of technical bid.

#### I. PRE-DISPATCH INSPECTION

- 1. Pre-Dispatch Inspection of Silent DG Sets shall be carried out by a team of Officers nominated by Embassy of India, Yangon at the office/factory of the Seller wherever situated in Myanmar prior to delivery of the item to ascertain that the item to be delivered are as per ordered technical specifications and of the acceptable quality. A set of all the diagnostic tools and techniques to test Silent DG Sets shall be provided by the vendor to the team of Officers sent by Embassy of India, Yangon alongwith the physical inspection and testing schedule prior to inviting Embassy of India, Yangon for inspection and testing of the items at the vendor's office/factory. The items must be as per ordered technical specifications or higher technical specifications only. No incomplete systems will be accepted under any circumstances. The systems should also contain same subsystems (brand/make) as quoted in the tender.
- 2. Failure to fulfill any of above mentioned conditions will lead to the rejection of the items during inspection and acceptance testing of the items.
- 3. If at any stage during Pre-Dispatch Inspection, it is found that ordered items are not ready or not of acceptable quality, Embassy reserves the right to cancel the Purchase Order and forfeit the Earnest Money Deposit.
- 4. Vendor has to get Pre-Despatch Inspection of all Items conducted within 6 weeks of the placement of Purchase Order. Delivery of all items to be completed within next 2-3 weeks. The installation of all the items in the respective sites will have to be completed satisfactorily within twelve weeks from the date of issue of the purchase order to the vendor failing which the Purchase Order may be cancelled.
