Request for Expression of Interest

1. Scope of work

Embassy of India, Yangon invites expression of interest for empanelment of vehicle dealer/agency for the supply of vehicles for the projects implemented in Myanmar by the grant assistance of Government of India. The vehicles shall be purchased for the various projects implemented in Myanmar with grant assistance of Government of India.

2. Eligibility Criteria

The agency/vehicle dealer shall possess the requisite resources, experience and capabilities in supplying necessary vehicles to meet the requirement that will be mentioned in the tender document whenever Embassy of India intends to procure vehicles for the various projects implemented in Myanmar with grant assistance of Government of India. The agency that fully meet the following requirement and provide satisfactory evidence, failing to do, the Embassy of India may reject.

- (i) Bidder shall be an agency/vehicle dealer engaged in supply of various model of vehicles in Myanmar.
- (ii) The agency/vehicle dealer shall have a valid company registration in Myanmar with approval of appropriate Government authorities (signed copy of document to be furnished).
- (iii) Average annual financial turnover statement during the last 3 years (signed copy of document to be furnished).
- (iv) Annual sales details of the agency for the past 3 years.
- (v) The agency has to provide an undertaking indicating that the agency/ vehicle dealer has not been banned or blacklisted by any Government/Ministries & Departments of Myanmar during the last 5 years (signed copy of document to be furnished).
- (vi) The agency must be in position to supply in any part of Myanmar.

- 3. Embassy of India reserves the right to accept or reject any or all expression of interest without quoting any reason.
- 4. Embassy of India will evaluate and compare the information furnished by the agency/vehicle dealer.
- 5. Embassy of India has a right to seek further details and other required documents from the agency/vehicle dealer before finalization of empanelment.
- 6. The empanelment is for the period of 5 years. However, extension of this period may be decided by Embassy of India.
- 7. The Last date of submission of Expression Of Interest is 16/11/2018 at 1500hrs. Opening of Bid is on 16/11/2018 at 1700hrs.

Expression of interest in the format must be submitted in a sealed envelope clearly superscribed "Expression Of Interest (EOI) for empanelment of agencies for supply of vehicle" along with all relevant documents to the "First Secretary (Development Cooperation), Embassy of India, No. 545-547, Merchant Street, Post Box No. 751, Yangon, Myanmar". Expression Of Interest sent through Fax or email will not be accepted.
